

TERMS & CONDITIONS

YOUR TRIP INCLUDES

- A Tailor Made Itinerary
- Confirmed Services, Accommodation, Activities & Events. (Subject to availability)
- All Services, Accommodation, Activities & Events are pre-paid prior to tour commencement.
- Breakfast daily at each specified Accommodation
- All Transfers & Touring with Professional Driver Guide and all related driver expenses.
- Personal assistance / advice regarding all activities and events.

YOUR TRIP EXCLUDES

- Personal Travel Insurance
- International Flights To / From Your Destination Country
- Meals (excluding breakfast) unless specifically requested and agreed at time of booking
- Entrance to Attractions unless specifically stated on itinerary and agreed at time of booking.
- Gratuities
- Golf Club or Buggy Rental unless specifically stated on itinerary and agreed at time of booking.
- Caddie Fees unless specifically stated on itinerary and agreed at time of booking

BOOKING ACCEPTANCE

- A booking is accepted by Treasured Ireland, only when we have received payment of a 25% non-refundable deposit and confirmed your booking by email if your booking is made more than 6 weeks in advance of your tour commencement or when we have received payment in full and confirmed your booking by email if your booking is made less than 6 weeks before your tour commencement.
- We require a 25% deposit to secure services and accommodations. **This deposit is non-refundable.**
- Golf bookings will require 100% payment at time of booking. **This payment is non-refundable.**

CANCELLATION

- **All Deposits are Non- Refundable**
- If your trip is cancelled more than 6 weeks prior to the tour commencement you will receive a 75% Refund if your trip has been pre-paid in full at that stage.
- If your trip is cancelled less than 6 weeks prior to the tour commencement you will forfeit 100% of the cost.
- If you cancel pre-booked and pre-paid golf you will forfeit 100% of the cost

PERSONAL TRAVEL INSURANCE AND TRAVEL DOCUMENTATION

- The price of your booking does not include your travel insurance and Treasured Ireland cannot recommend strongly enough to each client the importance of purchasing adequate comprehensive travel insurance to cover for cancellation, medical expenses and cost of assistance (including repatriation) in the event of accident or illness, personal injury/death; loss of baggage, all personal items and money; and all other expenses.
